**Authorization for Treatment and Financial Policy:**

I am 18 years of age or older and do hereby authorize the veterinarian and technicians to examine my pet and administer vaccines and treatment as is considered necessary for my pet's condition. A treatment plan of care options will be discussed prior to any treatments. In life-threatening situations, stabilizing care may be instituted upon arrival, but no invasive or diagnostic treatment will be undertaken until it has been discussed with me. I understand that CRAH may refuse services for any reason. Any pet left in the hospital for a period of 10 days or more will be considered abandoned under Ohio Revised Code. If my pet is labeled "abandoned" I remain responsible for all financial obligations to CRAH.

I hereby release CRAH of all liability in the event of injury, bite, fall or other circumstance that might cause injury while I/my family members am/are a visitor or patron in the hospital. I assume all risks and will take necessary precautions regarding safety in all non-public areas of the hospital for myself and my family.

I agree to pay for all services rendered on behalf of my pet at the time of release. An initial payment will be required for all hospitalized and surgical patients. We accept cash, debit card, credit cards and Care Credit. As of December 1st, 2014 we will no longer accept checks as a form of payment. *If cost is an issue, please discuss this with a client care specialist prior to treatment.*

I authorize Cleveland Road Animal Hospital and The Pet Hotel to use, reproduce and/or publish photographs and/or video of my pet(s). I understand this material may be used in various company publications, publicity, advertising, Web and Face Book content without payment or any other consideration.

In the event of an emergency, when deemed necessary, the doctors and staff of Cleveland Road Animal Hospital will perform Cardiopulmonary Resuscitation (CPR) on every pet. These types of emergencies are very rare, however we want to be prepared to provide your pets the appropriate care authorized by you. Unfortunately, CPR is oftentimes unsuccessful in veterinary patients, and no guarantees are made for a successful outcome. The cost of CPR would be in addition to your written estimate.
